#### Sue Haslam and Steve Simpson

Do you think the Radical Statistics Group is too laid-back? Do you think it is of value? Do you think we could be more effective? We want to know what you think.

To increase the impetus we thought a survey of membership was an appropriate course of action. We want to know more about you, what your views are on Radical Statistics and whether or not you can make a positive contribution.

The first draft of the questionnaire was piloted at the Radical Statistics Annual Conference in February. Although we have been back to the 'drawing board' several times since then, it formed the basis of the questionnaire circulated with this Newsletter.

The Radical Statistics Group has been in existence since 1975 and this is the first time we have carried out a survey of membership that goes wider than the encouragement to get involved in one of our projects.

We are fortunate to have the assistance of a computer studies student who is making the computation of the results form the basis of her final project. To gain the optimum benefit from this student resource, we not only want a response from you, but we want it quickly. She is available **now**.

In anticipation of your response - thank you. The results will be published in the winter Newsletter.

The discussion after the talk took up some of the difficulties faced by the ending of the Cold War. These included the problems of adjustment to the decline in demand from the military sector and its knock-on effects, the security problems that this could present in areas where there was a significant superpower military presence which could leave a vacuum and greater instability. Although on a more positive note the opportunities made possible by a safer world have presented themselves as an opportunity which should not be missed and one which RADSTATS might have an important role to play by pointing to the gap between opportunity and reality.

## **Annual General Meeting Report**

At the end of the Annual Conference there was time set aside for reports from subgroups, and other proposals. This was the AGM. The **Education Group** have not been active in the last year, and had no annual report to submit.

## **Health Group Report**

The Group is hoping to hold three or four meetings annually at the London School of Hygiene. The first of these was due to be held on 21 March when health and homelessness was to be discussed. Later the group indicated that weekend meetings may be possible. A request for volunteers to help with work on the new *Unofficial Guide to Health Statistics* was made to the AGM. The unallocated topics include GP statistics, dental statistics and statistics on healthcare outside the NHS.

The Group are updating Facing the Figures. It has been both time-consuming and very hard work. A suggestion was made that individuals could work on specific chapters and allow these to be issued as pamphlets. This will be considered by the Group. The Group are presently discussing whether Radical Statistics ought to liaise with the NHS Federation, which some felt was dominated by doctors.

## Troika Report

As noted in previous newsletters, a full list of the archives has been compiled. Requests for materials can now be made through our new address clearly indicating 'Publications'.

There have been two initiatives on publicity. Firstly Steve Simpson has had a letter published in the Guardian and Andrew Philpott Morgan and Steve have drawn up a publicity leaflet. This is being posted to every research department, trade union and university department in the country.

The last part of the AGM centred on a proposal from the Troika to have a publicity initiative on Official Statistics. The feeling of the Troika was that the issue of integrity of official statistics was very important. Specifically there was a proposal to have a public meeting with three speakers. Some people at the AGM felt that we may damage our standing with the Royal Statistical Society (RSS). It is very important to get our views clear. Was the concept of integrity clear to everyone? A compromise proposal to run a meeting in conjunction with the RSS was put forward, but could not be agreed since some people felt that the RSS had lost the opportunity for such a focus in the RSS report. The Chair suggested that the idea be brought back to the Troika for further discussion. Any offers of help or further ideas can be sent to any Troika member.

#### **Elections to Troiks**

Cecilio Mar Molinero was the only member of the Troika wishing to step down. Christy Maginn, Steve Simpson and Andrew Philpott Morgan were all willing to stay on, and were re-elected without a vote.

#### Vote of thanks

The Chair proposed a vote of thanks to Waqar Ahmed, Trevor Sheldon and Colin Thunhurst for organising the conference. It was clear that a lot of hard work was done in preparation for the day.

There was a request for anybody who wanted to take on the task for next year to contact the Troika.

### Notes on finance:

Events

Every category of income and expenditure was much higher in 1990 than in 1989! Subs went up, but so did administration, conference and newsletter costs - partly because of the full 3 issues this last year and partly because their postage was more fully paid for.

In the conference section, the 1990 one made a surplus of £53.79; there has been some advance publicity for the 1991 conference included in these accounts.

Overall we broke even in 1990. Income from subs will rise in 1991 with more paying at the rates decided in spring 1990, and new members from use of the promotional leaflet.

We have well over £1,500 in two bank accounts. I have put £300 in the 1991 budget for events such as the planned discussion of official statistics. There's plenty for other uses.
