

Business:

- 1) The next AGM will be held on 25 and 26 February 1994 in Birmingham. Tony Fielding and Ros Weatherall are organising it. It will be in the same venue as last year (St Francis Hall).
- 2) Philip presented preliminary accounts for the 1993 AGM. It appears to have made a modest profit of about £35. Some monies still have to be retrieved from the University. John will investigate setting up a separate AGM account at the Co-op. This would be used for all AGM income and expenditure and the signatories would be the treasurer (JB) and the AGM organisers.
- 3) Ludi handed over several boxes of paper and files which Anthony will mind from now on. The account signatories are being changed and John will find an accessible member to be a co-signatory. John will receive all mail from Alison and will forward the relevant bits to Anthony.
- 4) The current newsletter is doing fine, although it will be a bit late going out. The editors for the next two newsletters are Mark Selinger (Oxford) and Nicki Dennis (London). Nicki has also volunteered to get more book reviews in, Anthony will appraise Brendan Burchell of her offer.
- 5) Very few articles, well actually one, have been received for the Cathie Marsh memorial. John and Bob will take it forward over the summer, liaising with Mark Selinger to avoid undue competition for material. If enough material comes in, it could become a thin book, rather than effectively a fat newsletter. The costs of this will be investigated nearer the time.
- 6) Performance indicators. Susan Starkings and Andrew Pepper have expressed an interest in leading this further. Anthony's summary of the AGM discussion will be circulated further for comment and as a basis for action.
- 7) Ludi has volunteered to update the recruitment leaflet. It is a PageMaker document on his computer at work. Suggestions to Ludi a.s.a.p.
- 8) The next Troika meeting is provisionally scheduled to be on 22 September in Birmingham. Any major disagreements about timing and location to Anthony please.

- Provide an emergency back-up service

Philip reported that he had received a message from John Bibby stating that this task was more onerous than expected and that he was behind with the administration. It was agreed that the next meeting should be arranged, in Sheffield, to include a report from John and a review of the financial situation. Members should be encouraged to renew by Direct Debit.

7. Date of Next Meeting

To be arranged by Philip, after discussion with John Bibby, for the first week in December.

Radical Statistics Health Group (RSHG)

Notes of a Planning Meeting held on Saturday, 20 November 1993 at Bloomsbury Theatre, London, WC1

- 1. RSHG and Allyson Pollock has been approached for an article by David Seedhouse, of the new journal 'Health Care Analysis'. The suggested length is 3-4,000 words and there appears to be some flexibility as to the topic. It was agreed that it would be a good opportunity for the RSHG to put together something along the lines of 'How should we really be measuring the Health of the Nation?'. The international context could, of course, be covered. It was suggested that the following structure might be pursued, in each case identifying an RSHG member who might be happy to lead:
 - a. political/social context why is this an issue NOW? (Neil Vickers)
 - b. conceptual models of health (and health care?) (Allyson will ask Alex Scott-Samuel/Margaret Whitehead/ Mel Bartley)
 - c. Measurement what is measured and what should be measured? (Alison Macfarlane)
- 2. Azeem Majeed had been working with London Health Services Crisis Committee, including Harry Keen of the NHS Support Federation, to develop a protocol for a series of research projects to study the impact of post-Tomlinson developments in health care in London. Particular topics of interest include the transfer of acute care to 'community' settings (without a philosophical shift in service orientation?); the criteria for assessing bids and spending funds in primary care development. The King's Fund had indicated some interest in some of the ideas put forward but not the whole package.

Azeem agreed to pursue individual elements with the King's Fund (Angela Coulter) and to liaise with Harry about explicit involvement of LHSCC and NHSSF. Any further ideas would be welcome (tel: work 081-672-9944 x 56268, home 081-677-7765).

3. The group discussed its ability to respond rapidly to new developments in policy. For example, there is universal disquiet about the analysis of in-patient bed needs in the King's Fund report on London, which fed Tomlinson, but no rapid response publication from the group, well placed to articulate valid criticism.

Allyson suggested that a quick response could be made to Dr Mawhinney's recent published speech which again contained misleading use of statistics. More generally, she is considering a series of non-technical (eg newspaper) articles on different aspects of the current state of the NHS for mass readership. The group discussed ways in which members could obtain press-releases and notification of NHS-ME developments in enough time to be able to respond. Members are asked to make use of their official or other (press) contacts.

- 4. The revision of the Unofficial Guide to Official Health Statistics had rather ground to a halt at some point between 24 and 18 months ago. As before, the booklet is aimed at students, health professionals who are not stastical experts. CHCs and Trades Unionists. A number of contributions have already been made and Alison Macfarlane has started the work on collating these. They will need to be returned to the originators for updating and contributors will need to be identified for key areas that are missing. Mike Chambers is now drawing up a revised structure to the document and working on more specific guidance for contributors. The intention is to circulate the skeleton structure to those who are interested by mid-December and to request updated contributions/new contributions in the early New Year, to be delivered by the end of March. Mike and Alison are prepared to act as editors but would welcome some assistance. Kate Bloor volunteered to help with contacting people on the phone to motivate them to contribute. Any offers of help to Mike Chambers (tel: work 071-982-6391, home 0727-838873), Alison Macfarlane (tel: home 0727-852111) or Kate Bloor (tel: home 071-635-5451).
- 5. Any ideas are still sought on Health Care rationing and how we should continue to respond. Issues discussed at the meeting were the growth of co-payments - paybeds, over-the-counter drugs - and the inexorable transfer of the costs of care back to carers and the individual. Allyson suggested that we have a further discussion meeting on rationing, inviting RSHG members and also people on the database containing names of those who attended or showed an interest in last year's successful event. A related issue that was discussed is how actually to monitor community care. The process is being bogged down in a mass of paperwork and, therefore, could be open to considerable manipulation (corruption?) by street-wise providers of services.
- 6. The next Radstats conference will be on the last Saturday in February. The health group should ideally produce a speaker for the morning and devise an afternoon workshop. Ideas that generated some interest were those of 'League Tables' in health care, as in Education, and the current hot topic of 'outcome indicators' such as those presented in the recent DH package (and feasibility study by McColl and Gulliford). Neil Vickers agreed to canvas for ideas and possible speakers (tel: work 081-672-9944 x 56267; home 071-609-1856).

7. Allyson Pollock and Margaret Whitehead are planning a Society for Social Medicine conference on 19 May on 'Monitoring Equity in the NHS'. Contact either for further details: Allyson (tel: work 081-672-9944 x 56267; home 081-769-2514) or Margaret (tel/fax: 0948-664529).
